

# **GENERALI AKCJE: NOWA EUROPA**


**Equity** sub-fund



The investment objective of the sub-fund is a long-term increase in the value of assets as a result of investment value growth. Generali Akcje: Nowa Europa is the equity sub-fund. The sub-fund invests mainly in stocks of companies from the region of Central and Eastern Europe. Another object of sub-fund investments may be American depository receipts (ADR) or global depositary receipts (GDR).

On September 1, 2022, the investment policy and the name of the sub-fund changed. New name of the sub-fund – Generali Akcji Rynków Wschodzących.

#### **Dictionary**

Beta to WIG – this ratio shows the relation between changes in the value of a fund unit and changes in the WIG index. Beta of 1 means that changes in the value of a fund unit are the same as changes in the WIG index. Beta below 1 means that a growth (decrease) in the benchmark by 1% is usually connected with a growth (decrease) in the value of the WIG index by less than 1%. Beta over 1 means that a growth (decrease) in the WIG index by 1% is usually connected with a growth (decrease) in the value of a fund unit by more than 1%.

Sharpe's ratio - this ratio shows the profitability of risk borne by the fund compared to safe investments (e.g. treasury bonds). The higher the Sharpe's ratio. the lower the risk at which the return of the fund is generated compared to safe investments.

**Standard deviation** – this ratio shows how risky the given fund is. The higher the ratio. the more volatile the price of a fund unit. This ratio is used to compare the risk of funds with a similar profile (e.g. equity funds).
