# **GENERALI EURO** The first in Poland money sub-fund in EURO



The investment objective of the sub-fund is an increase in the value of the sub-fund's assets as a result of investment value growth. The Generali Euro invests funds primarily into money market instruments, public and corporate debt securities and covered bonds and certificates of deposit in domestic banks, foreign banks or credit institutions. The sub-fund invests assets in money market instruments and into other debt securities, in the case of which time to maturity does not exceed 397 days or interest rate is fixed for periods not exceeding 397 days, however instruments eligible as money market fund investments will not constitute a significant share. Share of other investment categories in sub-fund's assets may not exceed 30% assets value. Minimum 50% of assets are invested by the sub-fund into debt securities denominated in EUR.





#### **Asset allocation**



#### Dictionary

**Beta to benchmark** – this ratio shows the relation between changes in the value of a fund unit and the benchmark. Beta of 1 means that changes in the value of a fund unit are the same as of the benchmark, which suggests that the composition of instruments in the fund is the same as the composition of instruments in the benchmark. Beta below 1 means that a growth (decrease) in the benchmark by 1% is usually connected with a growth (decrease) in the value of a fund unit by less than 1%. Beta over 1 means that a growth (decrease) in the value of a fund unit by 1% is usually connected with a growth (decrease) in the value of a fund unit by 1% is usually connected with a growth (decrease) in the value of a fund unit by more than 1%.

**Information ratio** – this ratio shows the profitability of risk borne by the fund compared to its benchmark. The higher the information ratio, the lower the risk at which the return of the fund is generated compared to the benchmark. The fund with the information ratio over 0.3 is considered as effectively managed.

**Tracking error** – this ratio shows how risky the given fund is compared to its benchmark. The higher the ratio, the more aggressively is the fund managed compared to its benchmark. The ratio is used to compare the risk of funds with a similar profile (e.g. equity funds).

**Sharpe's ratio** – this ratio shows the profitability of risk borne by the fund compared to safe investments (e.g. treasury bonds). The higher the Sharpe's ratio, the lower the risk at which the return of the fund is generated compared to safe investments.

**Standard deviation** – this ratio shows how risky the given fund is. The higher the ratio, the more volatile the price of a fund unit. This ratio is used to compare the risk of funds with a similar profile (e.g. equity funds).

**Duration** – this ratio shows the change in the value of the debt part of the fund in reaction to a change in interest rates. The higher the duration, the bigger effect of a change in interest rates on a change in the value of a fund unit i.e. the higher the risk connected with the same.

**YTM** – (yield *to maturity*) – this ratio shows the rate of return that investors obtain when buying a bond at the current market price and holding it in their portfolio until maturity.
