we encourage you to obtain online access, which will allow you to view your savings balance in the Employee Capital Plan (ECP).

## SET UP ONLINE ACCESS

### What does online access give you?



You can check the amount of your savings in the ECP account at any time and from any place.



You can generate annual proof of all payments made to the ECP account by yourself.



You can submit selected orders and instructions on your own.



You can view the ECP maintenance contract.



You can indicate persons who are to inherit your savings.



You can open an IKE (Individual Pension Account) and IKZE (Individual Pension Security Account) free of charge. You can also transfer IKE and IKZE from another company to Generali Investments TFI S.A.



You can update your personal information once your identity is confirmed via the mojeld service.



You can manage the ECP product contact information on your own once the change is confirmed with a one-off authorization code.

### How to gain online access to the ECP?

Simply **open account** by selecting the option of identity confirmation through the mojeld service. The system will guide you through the steps of data verification up to the activation of your online access.
