The investment objective of the sub-fund is an increase in the value of assets as a result of investment value growth. Generali Profit Plus is a sub-fund of short-term corporate debt securities. The sub-fund applies the rules and investment limitations for a closedend investment fund. The sub-fund invests mainly in Polish debt securities issued by enterprises whose interest rate is fixed for periods not longer than 397 days or that have a residual maturity of 397 days or less. Another object of sub-fund investments may be debt instruments issued by state governments. The sub-fund may also invest in foreign debt instruments and hedge exchange rate risk by investing in derivatives.







### Dictionary

**Sharpe's ratio** – this ratio shows the profitability of risk borne by the fund compared to safe investments (e.g. treasury bonds). The higher the Sharpe's ratio, the lower the risk at which the return of the fund is generated compared to safe investments.

**Standard deviation** – this ratio shows how risky the given fund is. The higher the ratio, the more volatile the price of a fund unit. This ratio is used to compare the risk of funds with a similar profile (e.g. equity funds).

**Duration** – this ratio shows the change in the value of the debt part of the fund in reaction to a change in interest rates. The higher the duration, the bigger effect of a change in interest rates on a change in the value of a fund unit i.e. the higher the risk connected with the same.

**YTM** – (yield *to maturity*) – this ratio shows the rate of return that investors obtain when buying a bond at the current market price and holding it in their portfolio until maturity.
